

**PUBLIC NOTIFICATION BYLAW NO. 655
VILLAGE OF BERWYN**

**BEING A BYLAW OF THE VILLAGE OF BERWYN, IN THE PROVINCE OF ALBERTA, TO ESTABLISH METHODS FOR
ADVERTISING STATUTORY AND NON-STATUTORY NOTICES IN THE VILLAGE OF BERWYN**

WHEREAS, pursuant to section 606 of the *Municipal Government Act*, a Council must give notice of certain bylaws, resolutions, meetings, public hearings or other things by advertising in a newspaper or other publication circulating in the area, mailing or delivering a notice to every residence in the affected area or by another method provided for in a bylaw under section 606.1; and

WHEREAS, pursuant to section 606.1(1) of the *Municipal Government Act*, a council may, by bylaw, provide for one or more methods, which may include electronic means, for advertising proposed bylaws, resolutions, meetings, public hearings and other things referred to in section 606; and

WHEREAS, the Council of the Village of Berwyn is satisfied that the advertising methods set out in this Bylaw is likely to bring matters advertised by these methods to the attention of substantially all residents, or groups or area of the Village to which the bylaw, resolution or other thing relates, or in which the meeting or hearing is to be held;

NOW THEREFORE, the Council of the Village of Berwyn, duly assembled, enacts as follows:

SECTION I – PURPOSE, NAME AND DEFINITIONS

Purpose

- 1. The purpose of this Bylaw is to establish methods for advertising statutory and non-statutory notices to the public within the Village of Berwyn**

Name

- 2. This Bylaw may be cited as the "Public Notification Bylaw".**

Definitions

- 3. In this Bylaw,**
 - a) "Act" means the *Municipal Government Act*, RSA 2000, as amended.**
 - b) "Council" means the duly elected municipal Council of the Village of Berwyn.**
 - c) "Public" means residents, groups or other stakeholders located within the corporate boundaries of the Village of Berwyn required to be notified by the Act or by a bylaw of the Village of a proposed bylaw, resolution, meeting, public hearing or other things referred to in the Act or a bylaw of the Village.**

- d) "Method" means the preferred method(s) chosen by the Council of the Village of Berwyn for advertising statutory and non-statutory notices to the public.
- e) "Village" means the corporation of the Village of Berwyn.

SECTION II – ADVERTISING METHOD

1. The notice of any proposed bylaws, resolutions, meetings, public hearings or other thing required to be given under the *Municipal Government Act*, or a bylaw of the Village, shall be advertised in accordance with the timelines prescribed in the Act or the bylaw by:
 - a) publishing in a local newspaper or any other publication circulating in the Villageor
 - b) publishing electronically by posting the notice prominently on the
 - i. Village website or
 - ii. any of the Village's social media sitesor
 - c) posting the notice prominently on the bulletin board provided for that purpose in
 - i. the Village Office or
 - ii. public library or
 - iii. community hall or
 - iv. municipal recreational facilities

SECTION III – SEVERABILITY

Severability

1. If any portion of this Bylaw is declared invalid by a court of competent jurisdiction, then the invalid portion shall be severed.


SECTION IV – EFFECTIVE DATE


Effective Date


